



MAIDSTONE RCMP REPORT

For the dates of: December 3-16, 2025, Maidstone RCMP responded to 155 calls for service, some of which include:

10 traffic collisions
102 provincial traffic offences
1 mischief
1 robbery
2 break and enters
2 vehicle thefts
3 False 911 calls

CALLS FOR SERVICE:

- On December 3rd, members responded to of a single vehicle collision near Paynton SK. Members found that a driver had lost control of their vehicle, entered the ditch, went through a fence, became airborne, and landed in a field. The driver and lone occupant of the vehicle was taken to hospital for treatment of minor injuries. As a result of investigation, an adult male from Milk River Alberta has been charged with driving while prohibited.
- On December 4th, members responded to an abandoned vehicle in the Wilton RM. Investigation showed the vehicle to have been reported stolen earlier that day from Lloydminster. An aerial drone with thermal camera was used to search the area with Battleford PDS conducting a ground search. No persons were found during this search. The vehicle was forensically examined by Maidstone RCMP and investigation is on-going.
- On December 5th, members responded to an abandoned vehicle in the Britannia RM. Members met with the vehicle owner on site who stated that his vehicle had broken down.
- On December 5th, members responded with RM of Wilton Police Service to a report of suspected stolen property at a business in the RM of Wilton. As a result of the investigation, an adult male from Lloydminster has been charged with trafficking in stolen property.
- On December 6th, members responded to a residential alarm in the Wilton RM. Members searched the property and met with key holder who allowed members into the home. Investigation showed that the call was a false alarm.
- On December 6th, members received a call from a property owner in the Britannia RM. The caller was checking their firearms and found that two of them were missing. The firearms were last seen two years ago.
- On December 6th members responded to an abandoned vehicle in the Britannia RM. Investigation showed that the vehicle was not stolen and had become disabled while being operated. Vehicle did not pose a danger to the public and was left for the owner to resolve.
- On December 7th members responded to an abandoned vehicle in the Britannia RM. Investigation showed that the vehicle was not stolen and had become disabled while being operated. Vehicle did not pose a danger to the public and was left for the owner to resolve.
- On December 10th, members responded to a residential alarm in the Britannia RM. Members searched the property and contacted the homeowner who was unavailable to attend. Investigation showed that the call was a false alarm.
- On December 11th, members responded to a break-in at an abandoned property in the Britannia RM. Small household items were stolen from the property. There are no further investigational avenues or leads at this time.
- On December 11th, members responded to a call of property theft from trucks at a worksite in the Wilton RM. One stolen item was equipped with a GPS tracking device. During investigation, it was discovered that this item was recovered by a good Samaritan and members were able to return this item to the rightful owner. This file is still under investigation.
- On December 13th, members responded to a report of a suicidal male in the Town of Marshall. Investigation showed that the male was heavily intoxicated and was not a danger to himself. The male was left in the care of their sober family.
- On December 13th, members responded to a vehicle fire in the Paynton RM. Investigators spoke with the owner of the vehicle who stated that it had broken down on the side of the road two weeks ago. There are no further investigational avenues or leads at this time.
- On December 14th, members responded to a break-in at a property in the Britannia RM. A storage building was entered but nothing stolen. There are no further investigational avenues or leads at this time.
- On December 15th, members responded to a complaint of an unknown male who was believed to be living in a park in the Town of Marshall. Members attended, patrolled the area, and spoke with local business owners. The reported male was not located.

- On December 15th, members responded to a complaint of an unknown person sitting on the side of the highway in the Britannia RM. Members patrolled the area but were unable to locate any persons in the area.

TRAFFIC SAFETY

Impaired Operation:

- On December 5th, members conducted a traffic stop with a vehicle in the Town of Maidstone. As a result of investigation, the adult male driver from Maidstone Saskatchewan was found to be intoxicated on beverage alcohol resulting in Provincial Offence charges and a license suspension.
- On December 6th members conducted a traffic stop in the RM of Eldon. As a result of investigation, the adult female driver from Glaslyn Saskatchewan was found to be intoxicated on beverage alcohol resulting in Provincial Offence charges and a license suspension.
- On December 7th, members conducted a traffic stop in the RM of Britannia. As a result of investigation, the adult male driver from Marwayne Alberta was found to be intoxicated on beverage alcohol resulting in Provincial Offence charges, a license suspension, and their vehicle impounded.
- On December 7th, members conducted a traffic stop in the RM of Britannia. As a result of investigation, the adult male driver from Lloydminster Saskatchewan was found to be intoxicated on THC and cocaine resulting in Provincial Offence charges, a license suspension, and their vehicle impounded.
- On December 7th, members conducted a traffic stop in the RM of Britannia. As a result of investigation, the adult male driver from Cold Lake Alberta was found to be intoxicated on THC resulting in a license suspension and their vehicle impounded.

Speeding:

- On December 7th, members on patrol in the Britannia RM found a vehicle travelling at 141km/h in a zone with a posted speed of 100km/h. As a result of investigation, an adult male from Medicine Hat Alberta was charged with operating a vehicle at a speed greater than 35KM over the applicable speed limit and received a \$578.00 fine.
