



## MAIDSTONE RCMP REPORT

**For the dates of: December 17-30, 2025, Maidstone RCMP responded to 96 calls for service, some of which include:**

4 traffic collisions  
56 provincial traffic offences  
2 mischief  
2 robbery  
1 False 911 call

### CALLS FOR SERVICE:

- On December 19<sup>th</sup>, member received a report of 800 litres of fuel and extension cord stolen from a work site in the RM of Eldon. Unknown persons syphoned fuel out of vehicles at the work site. There are no further investigational avenues or leads at this time.
- On December 19<sup>th</sup>, members received a report of an abandoned vehicle in the RM of Britannia. Investigation showed that the vehicle wasn't stolen and had become disabled while being operated. Vehicle did not pose a danger to the public and was left for the owner to resolve.
- On December 19<sup>th</sup>, members received a request for a wellbeing check on an adult male in the Village of Paynton. Members attended and spoke with the homeowner who was well and in good spirits.
- On December 20<sup>th</sup>, members received a report of a hitchhiker walking along the side of the road in the RM of Wilton. RM of Wilton Police located an adult male from Fishing Lake First Nation and drove him to a safe place.
- On December 20<sup>th</sup>, members received a call from a motorist who had broken down in the RM of Wilton. Driver was provided with contact information to call a tow truck.
- On December 20<sup>th</sup>, members assisted the Saskatchewan's Coroner's Office with the investigation into a deceased male in the RM of Eldon. Investigation showed that the death was the result of natural causes.
- On December 20<sup>th</sup>, members responded to a 911 call from a cell phone in the RM of Britannia. No voice contact was made with the caller and no answer on call back. Members patrolled the area where the call was made from but located no persons in the area.
- On December 20<sup>th</sup>, members assisted EMS with the report of an adult male in the Town of Lashburn suffering from a stroke. Investigation showed the adult male had consumed too much cannabis and was cleared by medical staff.
- On December 21<sup>st</sup>, members responded to a report of a person walking along the highway in the Rm of Wilton not dressed for the weather. Members located an adult female from Onion Lake First Nation and drove her to a safe place.
- On December 21<sup>st</sup>, members assisted EMS with a report of a male with an injured leg on a work site in the RM of Wilton. An adult male from Medicine Hat Alberta was transported by EMS to hospital for treatment of their injuries.
- On December 21<sup>st</sup>, members received a request for a wellbeing check on an adult female in the Town of Maidstone. Members attended and found that EMS had also been called and were on scene treating the adult female.
- On December 21<sup>st</sup>, members received a report of a child welfare concern. Investigation showed that there were no children in danger and the matter should be referred to Child Welfare Service and Saskatchewan Family Court for a proper custody order.
- On December 22<sup>nd</sup>, members received a report of a person walking along the highway in the RM of Eldon. Members attended and located an adult male from Lloydminster Alberta. The adult male was driven to a safe place.
- On December 22<sup>nd</sup>, members responded to a complaint of an unwanted person at a residence in the Town of Lashburn. As a result of investigation, an adult female from Lloydminster Saskatchewan has been charged with one count of mischief under \$5000.
- On December 23<sup>rd</sup>, members responded to a commercial alarm at a business in the Town of Maidstone. Investigation showed that it was a false alarm due to a known malfunction with the security system.
- On December 23<sup>rd</sup>, members responded to a report of an abandoned and burnt vehicle in the RM of Britannia. Investigation showed that the vehicle was on private property and had been towed there at the request of the owner.

- On December 23<sup>rd</sup>, members received a report of threats received by a youth in the Town of Lashburn. Investigation showed that the messages came from a family friend and that there had been a misunderstanding.
- On December 23<sup>rd</sup>, members received a report of a stolen 2005 Jayco Feather 29' travel trailer in the RM of Wilton. Investigation is ongoing.
- On December 23<sup>rd</sup>, members responded to a complaint of squatters on a rural property in the RM of Eldon. Members investigated abandoned vehicles and items on the property and located the unwanted person. The unwanted person was informed that they were trespassing and instructed to remove their property.
- On December 25<sup>th</sup>, members responded to a report of an unknown person asleep in the lobby of a business in the Town of Maidstone. Members attended but the person had already left. Members patrolled the area but were unable to locate the person.
- On December 25<sup>th</sup>, members responded to a report that a motorist had dropped off a person in the rural area in the RM of Eldon and they were concerned for their safety. Members attended and patrolled the area but no persons were located.
- On December 26<sup>th</sup>, members responded to a report of a person walking along the highway not dressed for the weather in the RM of Wilton. Members patrolled the area but were unable to locate any pedestrians in the area.
- On December 26<sup>th</sup>, members responded to a complaint from a resident in the Village of Waseca reporting that their neighbours were pushing snow onto their property. Members attended and found that this was part of an ongoing neighbourhood dispute. Members mediated the current issue and left.
- On December 27<sup>th</sup>, members received a call from a motorist who had become stuck while travelling in the RM of Wilton. The adult male driver from Missisauga Ontario was uninjured and was provided with contact information to call for a tow truck.
- On December 27<sup>th</sup>, members responded to a report of an unwanted person at a residence in the Village of Waseca. An adult male from Mashall Saskatchewan was arrested on outstanding warrants and later released with a court date in Lloydminster Saskatchewan.
- On December 28<sup>th</sup>, members received a theft complaint in the RM of Britannia. Investigation showed that the matter was a civil dispute that members mediated.
- On December 28<sup>th</sup>, members responded to a family dispute in the RM of Wilton. Members attended and found that the family had resolved their issues and police were no longer needed.
- On December 29<sup>th</sup>, members responded to a report of an unknown person laying on the side of the road, near a vehicle, making snow angels in the RM of Britannia. Members attended and patrolled the area but located no persons or vehicles.
- On December 29<sup>th</sup>, members received a call from an adult male from Saskatoon Saskatchewan who was driving in the RM of Eldon reporting that the roads were icy and he was unable to contact the Department of Highways.
- On December 30<sup>th</sup>, members received a report of a person walking along the highway in the RM of Wilton. Members patrolled the area but were unable to locate any pedestrians.
- On December 30<sup>th</sup>, members received a report of a potential online fraud. The caller responded to an online ad for a snow mobile and provided a deposit to the seller. After several conversations the buyer became suspicious and has requested a refund. Investigation is ongoing.

## TRAFFIC SAFETY

- On December 18<sup>th</sup>, members received a one-week delayed reporting of a hit-and-run driver in the RM of Paynton. The reporting driver was struck in an intersection by a Chevrolet truck with unknown license plate and unknown colour. There are no further investigational avenues or leads at this time.
- On December 19<sup>th</sup>, members stopped a vehicle in Lashburn Saskatchewan for a burnt-out headlight. As a result of investigation, an adult male from Lashburn Saskatchewan was found to be intoxicated on THC and received a driver's license suspension.
- On December 20<sup>th</sup>, members responded to a report of a two-vehicle collision in the RM of Eldon. Investigation showed that a passenger vehicle slid through an intersection and struck the rear of a commercial vehicle. The commercial vehicle did not stop and it is uncertain if the driver of the commercial vehicle knew they had been struck. No injuries were reported and vehicles involved had minor damage.
- On December 21<sup>st</sup>, members stopped a vehicle for speeding in the RM of Eldon. As a result of investigation, an adult male from Galivan Saskatchewan was found to be intoxicated on THC and received a license suspension. A sober and licensed driver in the vehicle was allowed to drive from the scene.
- On December 23<sup>rd</sup>, members responded to a single-vehicle collision in the RM of Wilton. Investigation showed that the driver of the vehicle had lost control on the icy roadway causing the vehicle to veer into the ditch and roll over. The adult male driver from Grand Prairie Alberta was transported by family to hospital for minor injuries.

- On December 27<sup>th</sup>, members responded to a report of a single vehicle collision in the RM of Wilton. Investigation showed that the driver of the vehicle became disoriented due to the poor weather and drove into the ditch where they became stuck. The adult male driver from the RM of Wilton was found to have no injuries and arranged for their own tow.
- On December 27<sup>th</sup>, members responded to a two-vehicle collision in the RM of Eldon. Investigation showed that a passenger vehicle had changed lanes into the path of a commercial vehicle and was struck in the rear. There were no injuries reported and both vehicles had only minor damage.
- On December 28<sup>th</sup>, members stopped a vehicle for speeding in the RM of Britannia. Investigation showed that the adult female driver from Marwayne Alberta was intoxicated on beverage alcohol. The driver received a license suspension and their vehicle was impounded.
- On December 29<sup>th</sup>, members received multiple calls of a vehicle travelling the wrong way on a highway in the RM of Britannia. RM of Wilton Police assisted Maidstone RCMP by responding and located the vehicle travelling in the wrong lane. The vehicle became stuck in snow and contact was made with the driver. As a result of investigation an adult male from Sturgeon County Alberta has been charged with impaired operation of a motor vehicle.
- On December 30<sup>th</sup>, members responded to a complaint of an abandoned vehicle in the RM of Britannia. Investigation showed that the vehicle had been reported stolen in the Onion Lake area the previous day and that the license plate on the vehicle had been reported stolen that morning. The vehicle was examined forensically and the investigation is ongoing.
