



MAIDSTONE RCMP REPORT

For the dates of: January 27, 2026 – February 10, 2026, Maidstone RCMP responded to 147 calls for service, some of which include:

56 provincial traffic offences

CALLS FOR SERVICE:

- January 27th - Members responded to a complaint of an unwanted male at a residence in Maidstone. Members attended and arrested the intoxicated male who was held overnight and released when sober.
- January 27th - Members responded to a call of a vehicle on fire in the RM of Britannia with Britannia Fire. Truck was completely destroyed when emergency personnel arrived. Investigation found the truck was stolen from Lloydminster overnight.
- January 27th - Complainant of wanted individual being spotted at residence in Waseca. Individual was not located.
- January 27th - Report of possible trespassing in the town of Lashburn. Female youth spoken with who denied going onto the property. Youth advised stay away from property.
- January 27th - Report of male walking on Highway 16 near Marshall. Adult male located and taken to the hospital by police.
- January 28th - Several calls of vehicle in the ditch South of Paynton. Vehicle located. Nothing suspicious
- January 28th - Erratic driver on Highway 16. Vehicle was moving slow and could not maintain lane. Vehicle turned off shortly after the call. Members patrolled the area but the vehicle was not located.
- January 28th - 911 open line at residence in Maidstone. Determined to be kids playing with phone.
- January 28th - Report of bales falling off a semi truck on Highway 17 South of Lloydminster. Member in area located vehicle. Load was secure but straw was falling onto the highway.
- January 28th - A business in Maidstone reported a 350 gallon water tank stolen. File is still under investigation.
- January 28th - Female youth reported her older sibling was trying to assault her. Members attended and mediated the situation. Matter was resolved informally and referred to Child Family Services.
- January 28th - Report of vehicle blocking the road South of Paynton. Vehicle was gone when police arrived.
- January 28th - Tow company reported they pulled a vehicle out of the ditch in Paynton and the driver made it 20 feet before hitting the ditch again. Members attended. Investigation showed no signs of impairment. Driver was allowed to leave.
- January 29th - Report of possibly intoxicated male wandering around Maidstone. Members searched the area but did not locate anyone. No further calls.
- January 29th - Report of a Blue Dodge Ram truck swerving all over Highway 17. Member in area conducted patrols and did not see any vehicles matching description. No further calls.
- January 29th - Complaint of vehicle stuck near the Maidstone Hospital. Members located the adult male driver who did show signs of impairment due to alcohol. Driver issued a 3-day suspension and vehicle impounded for 3 days.
- January 29th - Members responded to a single vehicle roll over with EMS and Legacy Fire-Rescue on Highway 16 near Marshall. Driver tried to pass a semi but roads were icy. Driver taken to hospital by EMS and released.
- January 30th - Complaint of money taken from bank account. Found banking information had been entered into a fraudulent web site. Card cancelled.
- January 30th - Report of possible child abuse near Maidstone. Members worked with Child Family Services to determine the accusations were unfounded.
- January 31st - Report of male driving around Waseca with a prohibited firearm. Male located and arrested for outstanding warrant. Assault rifle located with unpinned 30 shot magazine. File is under investigation. Adult male from Waseca is appearing in court at a later date for possession of a prohibited weapon.
- February 1st - Report of possibly suicidal male in Maidstone. Male located by members and no concerns for the male's safety were noted.
- February 1st - Complaint of a domestic assault in Maidstone. Female had been pushed to the floor. Male

located and arrested. Male released on no contact conditions. Male to appear in court at later date.

- February 2nd – Report of sudden death of elderly female near Highway 303 in Britannia RM. Members attended with Saskatchewan Coroner and investigation determined the death was natural causes.
- February 2nd – Well-being check requested on male youth who was refusing to return home. Members located youth at residence in the RM of Britannia. The youth returned home the same day.
- February 3rd – Report of fraud in RM of Britannia. Victim had provided banking information to “Best Buy Geek Squad” after receiving a phone call. Still under investigation.
- February 3rd – Unwanted intoxicated female at a residence in Maidstone. Adult female arrested and held overnight then released when sober.
- February 4th – Members on patrol located vehicle in the ditch near Marshall. Driver smelled strongly of alcohol. As a result of investigation an adult female from Cut Knife was charged with impaired operation and driving while prohibited.
- February 4th – Stolen vehicle from Lashburn overnight. Grey 2013 Volkswagen Passat with Sask plate 761PBC entered on police systems as stolen. Still under investigation.
- February 4th – Information received of an assault rifle being stored on rural property near Lloydminster. Members got the landowner’s permission to enter the property. An imitation air-soft assault rifle located.
- February 4th – Report of theft from bank account in Maidstone. Victim received a phone call from credit card company advising of fraudulent use. Victim was provided a code to freeze his accounts. The code gave the fraudsters access to his accounts.
- February 4th – Member driving on Highway 16 near Lloydminster watched a semi-truck run over a stop sign as it entered Highway 16. Traffic stop initiated. Document checks showed the semi to be unregistered. Violation tickets issued.
- February 4th – Report of neglected youths at rural property near Maidstone. Members attended and determined there were no concerns. Referral sent to Child Family Services.
- February 6th – Collision on Highway 17 near Township Road 484. Driver of car ran into large truck which was part of a rig move. No injuries reported and minor damage to involved vehicles.
- February 6th – Report of an assault on rural road in the RM of Britannia. Female hit with weapon and thrown to the ground. Male then attempted to run the female over with a vehicle. Investigation is ongoing and an arrest warrant issued for Stephan REID of Lloydminster.
- February 7th – Female entered a residence in Lashburn and assaulted her ex-common law husband with a weapon. Female fled the scene before police arrived. An arrest warrant was issued and the female has since been located and released on court documents.
- February 7th – Report of an unknown male driving a grey Ford truck backed into a vehicle parked on Main Street in Maidstone. Driver gave the occupant of the other vehicle \$50 before driving off. Still under investigation.
- February 8th – Report of a male seen holding a rifle on Highway 16 between Paynton and Delmas. Multiple members from Maidstone Detachment and Battleford Detachment patrolled the area and did not locate anyone. No further complaints.
- February 9th – Child Family Services requested assistance with home visit in Lashburn. Members attended with CFS. Living arrangements found to be unsatisfactory and children removed.
- February 9th – Member on patrol located a stolen black 2011 Ford Edge with Sask marker 814PCN near Alcurve. Member attempted a traffic stop but the male driver fled at a high rate of speed southbound on highway 17 towards Lloydminster. Members did not pursue due to heavy traffic and public safety. Members patrolled the area and requested assistance from the Lloydminster detachment.
- On February 10th – Report of female being assaulted by her boyfriend on Highway 17 near Sandy Beach. Female had been punched in the face and left on the side of the highway. With assistance of the Onion Lake detachment the female was located and driven to the hospital. Warrant for Mathew BELL of Onion Lake issued.
- February 10th – Elderly male from the RM of Britannia reported he had been scammed for \$12,000 through a bitcoin fraud. Male had contacted what he believed to be a legitimate cryptocurrency company. The company had provided a code to the victim. The code allowed access into his bank account. Still under investigation.
- February 10th – Report of male staggering on Highway 16 near Marshall. RM of Wilton Police located a heavily intoxicated male at the location. Male was arrested for public intoxication and held until sober.
- February 10th – 911 hang up at residence in the RM of Britannia. Members were able to speak with homeowner and determined the children had been playing with the phone.

TRAFFIC SAFETY

- January 30th – Vehicle stopped for speeding. Driver showed signs of impairment and admitted to recently smoking marihuana. Driver tested positive for THC. Graduated driver received a 60-day license suspension.
- January 30th – Vehicle stopped for expired registration. Driver showed signs of intoxication and admitted to recent use. Driver tested positive for THC and Cocaine. Driver's license suspended 3-days and vehicle impounded.

WANTED

Brad MILLARD (50) of Maidstone, Saskatchewan is wanted for two counts of mischief under \$5000-damage to property and failure to appear in court.

Shawn WHITNEY (21) of Waseca, Saskatchewan is wanted for theft under \$5000-theft of gas and failure to appear for court.

Stuart MARTELL, 36, of Onion Lake, Saskatchewan is wanted for unsafe storage of firearms, carrying a concealed weapon, unauthorized possession of a firearm/prohibited weapon, possession of firearm/weapon/device ammunition in motor vehicle, adult possession of restricted firearm/prohibited weapon with ammo without licence/registration, fail to comply with release order condition and failure to appear in court.

Jeffrey MCLEAN (41) of Lloydminster, Saskatchewan is wanted for operation while prohibited, possession of property obtained by crime less than or equal to \$5000, pursuit involved – flight from peace officer, dangerous operation of motor vehicle, possession of property obtained by crime less than or equal \$5000, and operation while prohibited.

Justin NOETH (35) of Paradise Hill Saskatchewan is wanted for failing to comply with a probation order and failure to appear in court.

Stephen REID (44) of Lloydminster is wanted for assault and assault with a weapon.

Mathew BELLY (35) of Onion Lake, Saskatchewan, is wanted for assault.

Charlene LAMEMAN (45) of Lloydminster, Saskatchewan is wanted for mischief under \$5000 and carrying a concealed weapon.

Brednar SNAKESKIN (33) of Turtleford, Saskatchewan is wanted for 4 counts of failing to comply with his probation order.
